# **RULES OF**

# **CAMPING DU LAC D'HAUTIBUS**

According to the regulations, field Hautibus Camping is a tourist establishment whose exclusive purpose hosting campers using, as part of their leisure and temporarily shelter consists of a camping tent, caravan, mobile home or camper. Access the land is forbidden to anyone using one of these shelters, or as a means of permanent or long-term accommodation, either for commercial activities. Likewise it is forbidden for users to engage ground on it in every act of trade and any commercial advertising.

#### 1- CONDITIONS OF ADMISSION:

To be eligible to enter, settle, stay on a campsite, you have to have been authorized by the head of the reception desk, in the absence thereof, it is allowed to settle but it is imperative to report to the reception as soon as possible.

The fact of staying on the campground Lac implies acceptance of the provisions of this Regulation and the commitment to comply to them. Any violation will result in the expulsion of the author. In case of serious misconduct, the manager may use enforcement.

#### 2- POLICE FORMALITIES :

Any foreign national wishing to stay at least one night in the camp, must first, at present head of the Home Office's identity documents and complete the formalities required by the police.

# 3 - INSTALLATION:

The tent or caravan and associated equipment must be installed at the location indicated and as directed by the Manager. No direct water connection and direct sewage is planned.

Users must respect the general aesthetics of the campground, including the plot will not be encumbered by any other installation or movable property other than the caravan, or mobile home used in accordance with the regulations on full hospitality air.

4 – <u>RECEPTION</u>: Opening the campsite: from April 1 to September 30. Open from 8:30 to 11:30 and 16:00 to 19:00 (closed on Sunday), we find at the reception all information about camp services, information on refueling possibilities, sports facilities, tourist attractions in the surrounding area and various addresses that may be useful.

# 5 – <u>FEES:</u>

All fees are paid to the site office. Their amount is determined according to the published rate.

They are due to the number of nights spent on the field. Each night will count 12 to 12 p.m., upon installation on site, the next night is due.

For a stay of one or more weeks, each week will be payable in advance. Campers are encouraged to prevent reception office of departure on the eve of it.

Campers intending to leave before the opening of reception office hours the day before must make the payment of their fees.

## 6 - NOISE AND SILENCE:

Campers are urged to avoid all noise and discussions that might disturb their neighbours.

The sound should be adjusted accordingly. Car doors and vehicle noise should be as unobtrusive as possible.

Dogs and other animals must never be left to roam free. They should not be left in the camp, even locked in the absence of their masters who are civilly responsible. Their masters are responsible for the cleanliness of their animals.

Silence must be total between 22 hours and 7 hours

## 7 – <u>VISITORS:</u>

Visitors can be admitted into the camp under the responsibility of the campers who receive them, who must declare their number and their identity at reception.

If the visit lasts more than two hours, they are required to settle a fee per visitor. Visitors' cars are not allowed in the campground.

## 8 – VEHICLE TRAFFIC ANS PARKING:

Inside the camp the vehicles must run at a speed of 15 km / h. Traffic is prohibited between 22 hours and 7 hours.

Outdoor parking Parking: users are invited to take the usual precautions to safeguard their vehicles and equipment.

Can circulate in the camp that the vehicles belonging to campers staying. Parking should not impede traffic or hinder the installation of new arrivals. In high season, the vehicles will have obligatorily park on the plots of their users or to the car parks at the entrance.

## 9 - MAINTENANCE AND OBSERVANCE OF FACILITIES:

Everyone is obliged to refrain from any action that might prejudice the cleanliness, camp hygiene and appearance.

It is forbidden to throw dirty water on the ground or in the gutters.

"The caravan" must empty their wastewater in the facilities provided for this purpose.

Household waste, waste of any kind, the papers must be deposited in the bins provided.

It is forbidden to wash cars inside the campsite.

The sanitary facilities must be kept clean at all times by users.

Washing is strictly forbidden outside the bins provided for this purpose.

The spreading of the linen will, where appropriate, for drying. However it will be tolerated up to 10 hours near the shelter provided it is very discreet and does not bother the neighbours.

Plantations and floral decorations must be respected. It is forbidden to the camper to plant nails in the trees, to cut branches, to make plantations. It is not permissible to define the location of a facility by personal means, or

digging.

Persons will be held responsible for any damage to vegetation, fences, land or camp facilities.

The location that has been used during the stay must be restored to its original state.

Electric power supplied: 6 Amps

Off season, health will be closed.

Visitors' cars are not allowed in the campground.

# 10 – <u>SECURITY:</u>

a) - Fire

Open fires (wood- coal etc.) are strictly forbidden.

Stoves must be kept in full, safe, working order, and should not be used in a tent or near a car.

Fire extinguishers are available to everyone. In case of fire notify management immediately.

An essential first aid kit is located at the reception.

Campers are invited to take the usual precautions to safeguard their material.

b) – The management is not responsible for objects left at the office.

The camper is responsible for his own installation. Report immediately to the responsible presence in the camp of any suspect person.

c) – **Children** must be under the supervision and responsibility of their parents when they go to facilities and they use the toilet. For security reasons we remind that it is forbidden to play in health and it is not advisable to leave any child alone.

#### 11 – GAMES:

No violent or disturbing game can be organized near the installations. The meeting room can be used for the games provided. Children should always be supervised by their parents.

#### 12 - CARAVANS STORED ON SITE:

A caravan may be left unoccupied as hardware on the ground after management approval and only in the specified location. The campsite is not responsible for this hardware in the absence of the owner. A fee, the amount will be displayed in the office will be due for caravans stored on site.

## 13 – FENCING:

It is forbidden to add fences demarcating the other boundary markers without written permission of the Directorate locations. It is mandatory to leave a slot open side of the caravan side for emergency power out of the caravan site.

#### 14 – DISPLAY:

These rules are posted at the entrance of the campsite and at the reception desk. It is delivered to the customer on request

#### 15 - VIOLATION OF RULES:

In the case where a resident disturbs the stay of other users or does not respect the provisions of these rules, the manager or his representative may orally or in writing if he deems necessary, give notice thereof to cease disorders .

In case of serious or repeated breach the rules of procedure, and after notice by the Manager comply, it may terminate the contract.

In case of criminal offense, the manager may call the police.

Complaints forms are available to campsite users. Complaints will be considered only if they are signed, dated, as precise as possible and referring to relatively recent facts.
